### Membership and Bylaws Proposals

1.) The elected officers shall be elected by the procedures provided herein. The Secretary and Treasurer are to be elected for three-year terms. The Directors are to be elected for three-year terms, with five positions up for election annually. The Vice President is to be elected for a two-year term. After completion of his or her term as Vice President, and with the approval by a majority of the Board of Directors, he or she shall become President for a two-year term. After completion of his or her two-year term, the President will serve as Past President for one year after which, they may run again for a Board of Directors seat. The terms of office of each elected officer shall start on February 1 of the year of election and continue until a successor shall qualify.
